

NEWS FRAMING ANALYSIS: The Decreased of Ganjar Pranowo's Electability in the 2024 Election Contestation

Abstract: Elections serve as a means for Indonesian citizens to participate in shaping the direction of the country's politics and creating a government that represents the aspirations of the people. Mass media, including online news sites, play a crucial role in shaping public perception and opinions on political issues, including the electability of presidential candidate Ganjar Pranowo. This research aims to analyze the perspectives of online media outlets detik.com, kompas.com, and tempo.co in framing the news about the decreased in Ganjar Pranowo's electability after the Israel team's rejection statement, and Ganjar Pranowo being highlighted as one of the figures behind Indonesia's cancellation as the host of the FIFA U-20 World Cup. This research is of a qualitative nature, utilizing the framing analysis method. Furthermore, the framing analysis is conducted using the Zhongdang Pan and Gerald M Kosicki analysis model. The subjects of this study are news samples related to the decreased in Ganjar Pranowo's electability published on detik.com, kompas.com, and tempo.co online media on May 19, 2023. The results of this research indicate that the framing of online media detik.com and kompas.com related to the decreased in Ganjar Pranowo's electability tends to be positive. In contrast, the framing of tempo.co online media tends to be negative in reporting the decreased in Ganjar Pranowo's electability. This research is expected to provide a deeper understanding of how positive or negative media framing can influence public sympathy. Additionally, this study can raise awareness among the public about the potential influence of mass media on the political process and understanding how to consume news wisely and critically.

INTRODUCTION

Every election agenda is bound to generate issues or news laden with political interests. Mass media, as information disseminators, have long been considered to position themselves as neutral in every news reporting. However, in reality, mass media currently plays a significant role in every election. Mass media, including online news sites such as detik.com, kompas.com, and tempo.co, have a crucial role in shaping the perception and public opinion regarding political issues, including the news about potential presidential candidates for the Republic of Indonesia in the 2024 elections.

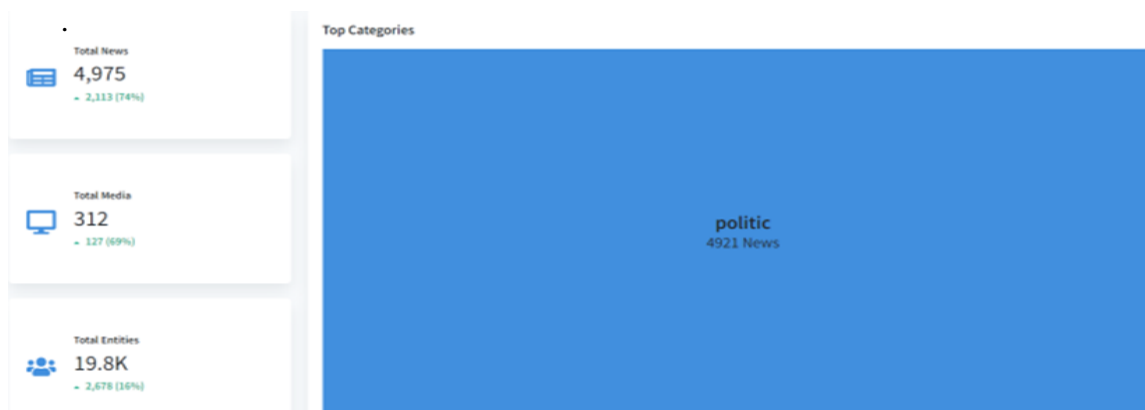


Figure 1. Statistical Report (Source: Netray.com)

As the 2024 political year approaches, media outlets are increasingly publishing articles related to presidential surveys from various survey institutions such as LSI and Netray.com. So far, there are three presidential candidates who are anticipated to compete in the upcoming 2024 Presidential Election: Anies Baswedan, Ganjar Pranowo, and Prabowo Subianto. These three potential presidential candidates are prominent figures in the media. Using the keywords "surveys & presidential candidates," one can find as many as 4,975 articles related to presidential surveys from a total of 312 media sources. All of these articles involve at least 19.8 thousand total entities. The dominant category in the news coverage is politics, accounting for nearly 99%, as indicated in Figure 1 below:

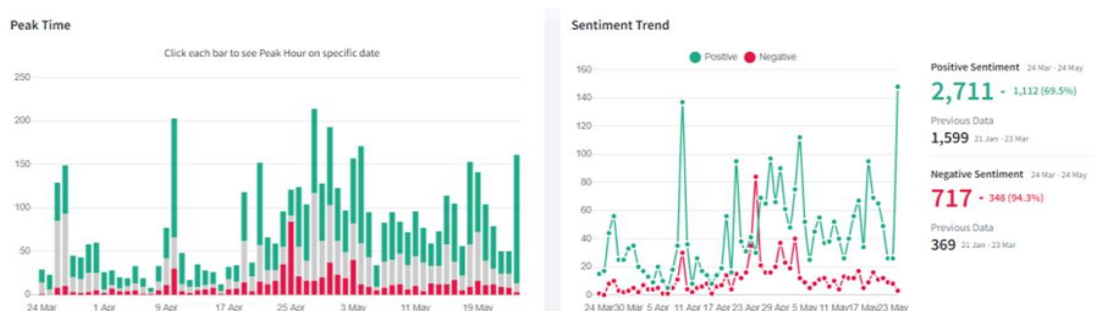


Figure 2. Coverage Intensity and Sentiment Trend (Source: Netray.com)

The increasing intensity of coverage related to this survey is certainly influenced by the approaching political year, leading to the declaration and support for several presidential candidates becoming more vibrant. The coverage intensity has been on the rise since late April 2023 until the end of the monitoring period, with a sentiment trend that tends to be positive, as shown in Figure 2 below:

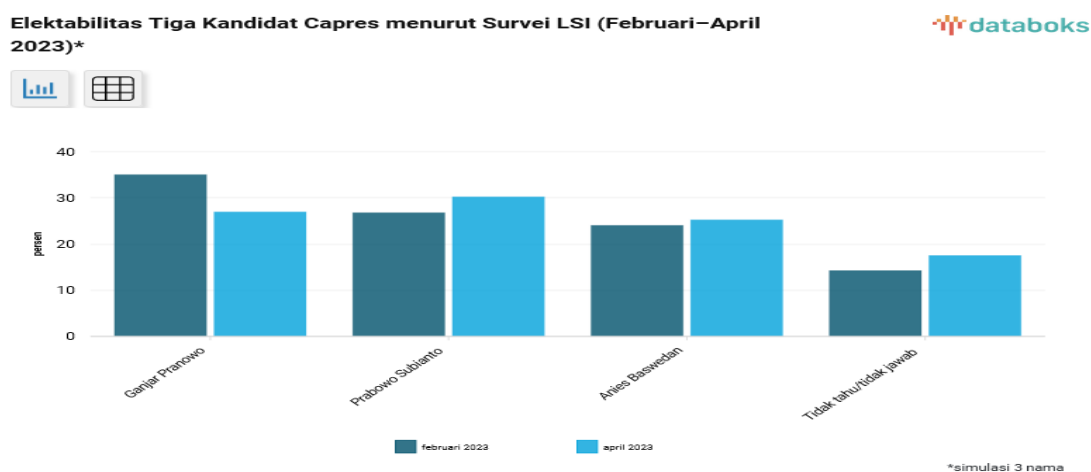


Figure 3. Percentage Graph of Electability for Three Presidential Candidates (Source: Netray.com)

Furthermore, based on the national survey data from LSI conducted from March 31 to April 4, 2023, the electability levels of the potential presidential candidates for 2024 have experienced both decreases and increases. According to the survey, it is revealed that Ganjar Pranowo has experienced a decrease to 26.9% from the initial 35% in February 2023, Anies Baswedan has seen a slight increase to 25.3% from the initial 24% in February 2023, and Prabowo Subianto has also experienced an increase to 30.3% from the initial 26.7% in February 2023. This is illustrated in Figure 3 below::

Based on Figure 3, it is evident that Ganjar Pranowo has experienced a significant decrease in electability. This could possibly be attributed to Ganjar Pranowo's statement rejecting the Israeli National Team from participating in the U-20 World Cup, which was planned to be held in Indonesia. Additionally, Ganjar Pranowo's name has been mentioned quite frequently as the party most responsible for FIFA's decision to revoke Indonesia's status as the host of the U-20 World Cup.¹

Media coverage plays a very important role in shaping the public's perception of presidential candidates or politicians. The use of framing or different presentation of news in the media can influence how the public understands, interprets, and responds to political information. Positive and negative framing in news media can impact the electability of presidential candidates in several ways, namely: (1) *Influence on Public Opinion*: News that provides a positive framing of a presidential candidate tends to help build a good image and increase popularity among voters. Conversely, negative framing can create doubts about the candidate, which can have a negative impact on their electability. (2) *Negative Bias Effect*: Negative framing in media coverage has a stronger impact than positive framing. Negative news tends to grab the attention of readers or viewers more, and negative information can leave a sharper impression than positive

information. As a result, if a presidential candidate is portrayed with negative framing, it can increase negative perceptions of them and impact their electability. (3) *Priming Effect*: Continuous or repetitive framing can influence priming in the minds of voters. If voters are consistently exposed to negative news about a presidential candidate, it can affect how voters evaluate the candidate's actions and statements. (4) *Polarization and Filter Bubbles*: Different framing can lead to polarization among voters. Voters tend to trust news that supports their views, creating filter bubbles where voters are only exposed to the same perspective. This can reinforce voters' beliefs in a particular presidential candidate and make them less receptive to information presenting different views².

In essence, media coverage can significantly shape public opinion and influence the electability of presidential candidates by affecting how voters perceive and respond to political information. It's important for both media consumers and political candidates to be aware of the potential impact of media framing on the electoral process.

The effects of media framing are indeed very complex and influenced by numerous factors, including the political context, voter characteristics, and the quality of the desired or consumed news sources. Additionally, technological advancements and changes in social media trends can also impact how voters receive and process political information. Based on the explanations provided above, analyzing the framing of news related to the decreased in Ganjar Pranowo's electability is an intriguing subject for research.

METHOD

This research employs a qualitative approach using the framing analysis method. Framing analysis is a useful method for understanding the perspectives or viewpoints used by journalists in selecting issues or events and presenting them in news intended for the general audience. Framing analysis, from the perspective of communication science, can be used to examine how reality is shaped and constructed by the media.

The researcher describes the framing of news from online media related to the decreased in electability of one of the potential presidential candidates for the Republic of Indonesia in 2024, namely Ganjar Pranowo. The focus of this research is the analysis of news coverage on online media platforms such as detik.com, kompas.com, and tempo.co, with the following details:

1. News Article from detik.com with the title "*LSI Denny JA Bicara Penurunan Elektabilitas Ganjar, PDIP Singgung Sponsor*" (detik.com, Mei 19, 2023)
2. News Article from kompas.com with the title "*Alasan Penurunan Elektabilitas Ganjar, LSI Denny JA: Piala Dunia U20 hingga Kemiskinan di Jateng*" (kompas.com, Mei 19, 2023)
3. News Article from tempo.co with the title "*LSI Ungkap Penyebab Elektabilitas Ganjar Pranowo Turun, Tak Hanya Soal Piala Dunia U-20*" (tempo.co, Mei 19, 2023).

The researcher examines and describes how detik.com, kompas.com, and tempo.co report on Ganjar Pranowo's electability. Furthermore, the researcher employs the framing analysis method according to Zhongdan Pan and Gerald M. Kosicki to depict the process by which media selects specific aspects of reality to highlight in their reporting³.

Below is a table outlining the framing structure according to Zhongdan Pan and Gerald M. Kosicki, which refers to how media organize and present news to the public. Both can be discussed in the context of syntactic, script, thematic, and rhetorical structures.

Based on Table 1, here is an explanation related to the framing structure according to Zhongdan Pan and Kosicki:⁴

1. **Syntactic Structure:** This relates to how journalists organize events, statements, opinions, quotes, and observations into the general structure of a news report. This can be observed from the news layout (the lead used, background, headline, selected quotes, and so on). Essentially, through syntax, we can observe how a journalist comprehends events by examining how they arrange facts into the general format of a news report.
2. **Script Structure:** This pertains to how journalists narrate or tell events in the form of news. This structure looks at the storytelling or narrative strategies employed by journalists in packaging events into news format.
3. **Thematic Structure:** This relates to how journalists express their views on events through propositions, sentences, or the relationships between sentences that form the

overall text. In discussing this structure, we examine how understanding is manifested in smaller forms within the text.

4. Rhetorical Structure: This pertains to how journalists emphasize specific meanings in news reports. This structure examines how journalists use word choices, idioms, graphics, and images not only to support the text but also to underscore specific meanings for the audience.

RESULTS AND DISCUSSION

Here are the results of the media framing analysis using the model of Zhongdan Pan and Gerald M. Kosicki regarding the decrease in the electability of Ganjar Pranowo:

1. News Article from detik.com with the title “*LSI Denny JA Bicara Penurunan Elektabilitas Ganjar, PDIP Singgung Sponsor*” (detik.com, Mei 19, 2023)⁵

Based on Table 2, it can be seen that the framing of the news article from detik.com is more informative and positive in nature. It provides detailed information about the survey results of presidential candidate Ganjar Pranowo's electability, which has experienced a decreased. The article includes electability figures for Ganjar Pranowo at various times, such as May 2022, January 2023, and May 2023. The details provided explain the three reasons disclosed by Adjie Alfaraby regarding the decreased in Ganjar Pranowo's electability. The news also presents the response of senior PDIP politician Hendrawan Supratikno to the survey results and the reaction of PDIP.

Based on Table 3, it can be observed that the framing of the news article from kompas.com is more informative and positive in nature. It provides detailed information about the survey results of Ganjar Pranowo's electability and the influencing factors, such as the cancellation of Indonesia hosting the U-20 World Cup in 2023, public perception of Ganjar's personality, and the failure to address poverty in Central Java. The news article also includes survey data details, electability figures, and discussion outcomes to support the analysis.

Based on Table 4, it can be observed that the framing of news from tempo.co tends to be negative and portrays Ganjar Pranowo in a corner by providing strong details about the negative aspects of his persona. This includes the results of surveys on Ganjar Pranowo's electability and the influencing factors. Ganjar is now seen as responsible for the cancellation of the FIFA U-20 World Cup in Indonesia, which has left 72 percent of the public disappointed, with 14.4 percent holding Ganjar accountable for the cancellation. Ganjar Pranowo is perceived as lacking strong leadership, as his party affiliation status makes him appear weak. Lastly, Ganjar Pranowo's poor performance in addressing poverty issues in Central Java Province, as assessed by the local residents, is also highlighted.

CONCLUSION

The coverage of the decreased in Ganjar Pranowo's electability in the online media outlets detik.com, kompas.com, and tempo.co can be summarized as follows: all three media outlets focus on reporting the primary reasons for the decreased in Ganjar Pranowo's electability. However, there are differences in the framing of their news content. The news framing regarding the decreased in Ganjar Pranowo's electability on detik.com and kompas.com tends to be positive, as their reporting is informative to the audience without containing persuasive elements. In contrast, the news framing on tempo.co regarding the decreased in Ganjar Pranowo's electability tends to be negative.

Based on the analysis results, tempo.co frames the coverage of Ganjar Pranowo's electability as an effort to provide statements and shape public opinion that Ganjar Pranowo is one of the reasons for the failure of Indonesia as the host of the FIFA U-20 World Cup. Additionally, tempo.co criticizes Ganjar Pranowo for his perceived failure in addressing poverty cases in Central Java over the past five years. The online media outlet also frames Ganjar Pranowo as a figure lacking character and authority, with the label of being a party functionary. This is evident from the overall news content that has been analyzed using the syntactic, script, thematic, and rhetorical structures.

Furthermore, it is expected that the results of this research can provide a deeper understanding of how positive or negative media framing can influence public sympathy. Additionally, this study can raise awareness among the public about the potential influence of mass media on the political process and provide insight into how to consume news wisely and critically.
